Background information and context was highlighted. The following minor policy revisions in Section (7) General Education Courses in the Curriculum Approval Policy for Ministry Approved Programs were presented for APCC's consideration, upon recommendation from Deans' Council:

- APCC to replace the Teaching and Learning Faculty Council for the New or Course Change for GNED-Prefixed Courses in the approval pathway; and,
- Addition of the Editorial Change for GNED-Prefixed Courses approval pathway.
