2.2.1. EC had a preliminary discussion on the idea of Tributes at GFC meetings. When a former GFC member and/or long-term contributor to MRU (i.e. a decade or more of service) passes away, a way of acknowledging their contributions could be a tribute at a GFC meeting.

Discussion:

- Comments were made in support of the idea and to draft guidelines.
- Preliminary feedback was given on considering family wishes for whether or not an individual receives a tribute, who would be eligible and included, who could do the tribute, and what if someone gets missed.

Next Steps:

• The University Secretariat will work with C. London to further discuss implementation considerations/timing and develop guidelines based on this preliminary discussion.

• These will be presented to EC for approval and shared with GFC.
