3. GFC September 20, 2024 Meeting Follow-ups

3.1. Follow-ups for EC

EC discussed two questions that arose at the Sept. 20 GFC meeting that were brought forward by the acting Chair, Chad London, on behalf of GFC for EC to consider:

- 1) Should there be a conversation with GFC about the Academic Indigenization Committee (AIC) earlier than bringing forward a GFC Bylaw change?
 - It was explained that at the September 20, 2024 GFC meeting, the question arose that if EC decides to recommend removing AIC from the GFC Bylaws, could a discussion with

- GFC as a formal agenda item occur prior to submitting a Notice of Motion to amend the Bylaws.
- EC discussed and considered when and if a conversation with GFC about AIC is most appropriate. It was affirmed that no additional Bylaw change/s are contemplated at this time. There was acknowledgement that any process that might result in recommended Bylaw change/s could include consideration around a broader discussion at GFC and that GFC bylaws enshrine the right of any member of GFC to raise concern on any issue before or after a Notice of Motion. There was discussion about when and how GFC might be engaged in a broader discussion on establishing an AIC committee. There was discussion regarding the various factors that have been previously discussed at GFC EC and in other forums. There was discussion around the reasons why the AIC has not yet been established, including timing of the work on the Indigenous Strategic Plan and advice from leadership in the Office of Indigenization and Decolonization.
- 2) Is there interest in having the Generative AI Working Group formally provide an update to GFC on a GFC agenda?
 - EC discussed and agreed that the GFC Chair and Vice-Chair Report will continue to include updates regarding the Generative AI Working Group's work.
- 3.2. GFC Governance Essentials Feedback
 The GFC Governance Essentials feedback from the September 20, 2024 session was reviewed.

EC will share the assessment results with GFC in November, and will discuss at their next meeting the approach/format for discussing the results with GFC in 2025.
