An additional note will be added to the report to clarify the differences between preferred accommodations and alternative accommodations that satisfy the institution's duty to accommodate.

A question was also asked about the consultation process for revisions to the Academic Accommodation for Students with Disabilities policy. The existing policy is currently with a review committee led by C. Rogerson and drafts will be submitted to SAC as part of the policy consultation process.
